A random sample of active voter rolls found 3% of individuals were deceased, another 3% relocated, and another 3% moved addresses. However, "there was no evidence that these irregularities suggest an unlawful vote was cast."

The study came to a consistent conclusion for each claim: no statistical evidence was found to back up these claims of fraud.
